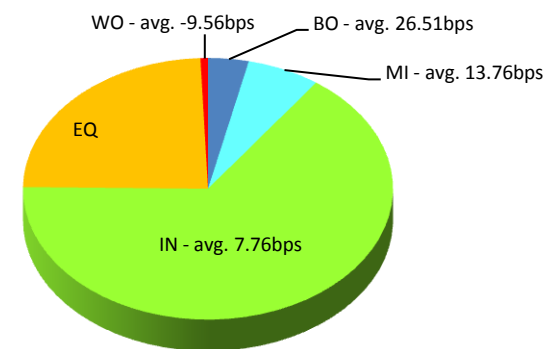
### Execution improvement patterns categorized into 5 groups.

- (5) **Worse ("WO")** – worse price than Primary Exchange

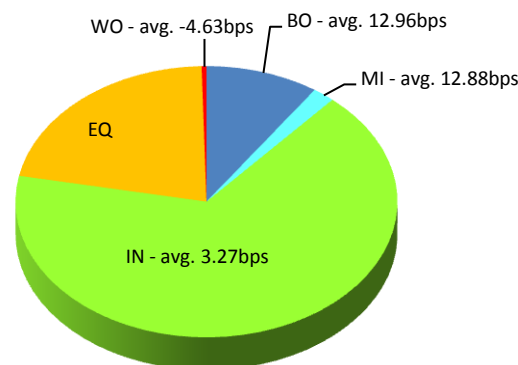
